NOTICE OF VARIATION TO MEMORANDUMS OF UNDERSTANDING RELATING TO THE COLLECTIVE PROCUREMENT OF COLLABORATIVE CONTRACT PRODUCTS AND SERVICES

- 1. Your organisation has entered into one or more Memorandums of Understanding (**MoUs**) set out in Appendix 1 to this notice of variation.
- 2. New Zealand Government Procurement (NZGP) is continuing to progress 'Procurement for the Future'. This is a large programme of work that will examine and improve the current procurement system to meet future economic, social and environmental challenges. 'Data and Transparency' is a key focus area for Procurement for the Future.
- 3. The purpose of this variation is to amend the MoUs to allow NZGP to disclose and publish data relating to Participating Agencies' procurement activities under the relevant collaborative contracts (including spend data with panel suppliers). This will help improve procurement practices of Participating Agencies and enable greater transparency.
- 4. The CoE can amend the MoUs on notice to Participating Agencies. The changes to the MoUs are set out in Appendix 2 (the **Variation**).
- 5. The changes made by this Variation shall be effective from 29 June 2023. Subject to the changes made by this Variation, the terms and conditions of the MoUs remain in full force and effect.
